STANDARD BANK/CHENIN BLANC CHALLENGE 2016 KOMPETISIEREËLS



Conditions of Entry

- Only market ready wines may be entered. No tank or barrel samples will be accepted.
- Where entries include (an)other cultivar(s), Chenin Blanc should make up at least 85% of the blend.
- Wines entered should not possess a residual sugar (RS) in excess of 12g/l. The organisers reserve the right to have this tested independently.
- There is no restriction on the number of wines that a producer may enter.
- All vintages accepted.
- If a wine has been selected as one of the Top 10 winning wines in either 2014 or 2015, that specific vintage of the wine may not be entered again.
- A minimum amount of 125 cases x 6 (750 bottles) of each wine entered must be available at the cellar, for sale in the local market, from the date of entry in the competition until the results are announced on 24 August 2016. The organisers reserve the right to check stocks by means of physical inspections.
- Winners will receive R20 000 each and the money must be used to reinforce the economic and social benefits in the workplace and to the workforce.

Entries

- Closing date for entries and submission of samples: **Wednesday 29 June 2016 (Membership fees must be paid by entry date).**
- Each entry must be accompanied by WSR2A certificate. (WSR2A must have full analysis of the wine.)
- **Completed entry forms, wine samples and proof of payment to be sent together to: STANDARD BANK/CHENIN BLANC CHALLENGE 2016, Villiera Wines, Stellenbosch.**

Entry Fees

- Members: R750-00 per wine. (Membership fees must be paid by entry date).
- Non Members: R1500-00 for first entry, which includes pro-rated membership fee until end of 2016. Additional wines' entry fee will be R750-00 per wine.

Vereistes vir deelname

- Slegs wyne wat markgereed is, mag ingeskryf word. Geen tenk- of vatmonsters sal aanvaar word nie.
- Waar inskrywings ander kultivar(s) insluit, moet Chenin Blanc ten minste 85% van die versnit wees.
- Die wyne wat ingeskryf word, mag nie ressuiker (RS) van 12 g/l oorskry nie. Die organiseerders behou die reg om dit onafhanklik te laat toets.
- Daar is geen beperking op die aantal wyne wat ingeskryf mag word nie.
- Alle oesjare mag ingeskryf word.
- Indien 'n wyn gekies is as een of the Top 10 wen wyne, in 2014 of 2015, mag daardie spesifieke oesjaar nie weer ingeskryf word nie.
- Minimum hoeveelheid van 125 kiste x 6 (750 bottels) van elke wyn wat ingeskryf word, moet vanuit die kelder beskikbaar wees vir die plaaslike mark, vanaf die inskrywingsdatum tot en met die bekendmaking van die resultate op 24 Augustus 2016. Die organiseerders behou die reg om deur middel van fisiese inspeksie die voorraad na te gaan.

Wine Samples

- 4 x 750ml bottles of each wine entered must be submitted to the judging panel for judging.
- Wine samples (4 bottles) of each entry must be packed separately in a carton.
- If the bottles have not yet been finally labelled, the following details are to be clearly indicated on a label on the bottles: Producer, Brand name, vintage and Wine of origin.
- **Wine samples must be delivered to Villiera Wines Stellenbosch ONLY from 27 to 29 June 2016 between 09h00 and 16h00.**
- Directions: Take exit 39 from the N1 highway, and travel 2km down the R304 in the direction of Stellenbosch. Villiera is at the T-junction on your right, opposite the Koelenhof Winery.
GPS co-ordinates - S33° 50' 14.4" E018° 47' 34.4"
- No late entries will be accepted.

Judging and Awards Function

- The judging will take place on **5-7 July 2016**.
- The 10 winning wines will be announced on **Wednesday 24 August 2016** at a lunch at Delaire Graff, Stellenbosch

Obligations of producers of winning wines

- The producers of the 10 winning wines must, when requested thereto, submit the following document: A copy of the WSR4A certificate by the Wine and Spirit Board.
- The winning producer will stick the Top 10 sticker to the bottle, before delivering the wines, as explained below.
- 100 bottles of winning wines to be made available to the sponsor, Standard Bank of SA, at trade price.
- 180 bottles of winning wines must be delivered to our trade partner, Wine of the Month club. A discount of 10% must be allowed on the trade price.
- 48 bottles of winning wines must be provided free of charge to the Chenin Blanc Association for marketing purposes.
- The 10 winning wines will be showcased at the Intrepid 2016 Wine Show in London, Sept 2016. The cost of participation will be covered by the CBA but the producers of the winning wines must provide the 4 bottles required for the show.

General

- Please note that entries without proof of payment will not be judged.
- Assessment will be done blind/labels out of sight.
- Stickers: 125 x 6 per winning wine will be supplied free to the producers. Extra stickers will be available for purchase on request.

Wynmonsters

- 4 x 750ml bottels van die betrokke wyn wat ingeskryf is word benodig vir beoordeling.
- Elke inskrywing se monsters (4 bottels) moet in 'n aparte karton verpak word.
- Indien die bottels nie finaal geëtiketteer is nie, moet die volgende inligting op 'n etiket op die bottel(s) aangebring word: Produsent, wynnaam, oesjaar en Wyn van Oorsprong.
- **Wynmonsters moet afgelewer word by Villiera Wyne, Stellenbosch ALLEENLIK 27 tot 29 Junie 2016 tussen 09h00 and 16h00.**
- Aanwysings: Uitgang 39 vanaf N1, na 2km op R304 (in rigting van Stellenbosch) by die T-aansluiting draai regs na Villiera, oorkant Koelenhof Wyne.

Beoordeling van wyne en toekenningsfunksie

Verpligtinge van produsente tov wenwyne

- Die produsente van die 10 wenwyne moet, wanneer versoek, 'n afskrif van die Wyn en Spiritus raad WSR4A sertifikaat indien.
- Die produsente sal die Top 10 bottelplakkers, op die bottels plak, voor die wyne afgelewer word, soos hieronder uiteengesit.
- 100 bottels van die wenwyne moet aan die borg, Standard Bank van SA, beskikbaar gestel word teen handelsprys.
- 180 bottels van die wenwyne moet by ons handelsvennoot, Wine of the Month klub afgelewer word. 'n Kortings van 10% moet op die handelsprys toegestaan word.
- 48 bottels van die wenwyne moet gratis aan die Chenin Blanc Assosiasie beskikbaar gestel word vir bemerkingsdoeleindes.
- Die 10 wenwyne sal geskenk word by die Intrepid 2016 wynskou in London, Sept 2016. Die koste om deel te neem aan die skou, word gedra deur die CBA maar die produsente van die wenwyne moet die 4 bottels wyn voorsien wat gebruik gaan word by die wynskou.
