

RULES AND PARTICULARS

By entering the competition, all participants confirm and agree that they have read, understand and shall comply with the following terms and conditions:

- Your entry into the competition and/or your acceptance of a prize (in the event that you win a prize) constitutes your binding acceptance of the terms and conditions on behalf of yourself and any person with whom you may share a prize (in the event that you win a prize which is for you and one or more additional persons ("your partner").
- The Organiser of the competition is Du Toitskloof Wines in conjunction with Multichoice's KykNet.
- The competition is open to all residents of South Africa who are 18 (eighteen) years old at commencement of the competition.
- The competition period will run from 11 July 2016 to 12 August 2016. The competition closes at 24:00 on 12 August 2016.
- Producers, directors, members, agents and employees of Du Toitskloof Wines, KykNet, with specific reference to KykNet, as well as the spouses, life partners, natural or adopted parents, children, brothers or sisters of any of the aforementioned, are not eligible to enter the competition.
- The winner of the competition will receive two VIP tickets to the Silwerskerm Film Festival taking place on 24 to 27 August 2016 at The Bay Hotel in Camps Bay, Cape Town, Western Cape province. The prize also includes accommodation and travel within South Africa. All travel and accommodation arrangements will be made in conjunction with the winner as far as possible, however, the final decision and arrangements will be taken at the sole discretion of the competition Organiser.
- To qualify for the draw of the competition winner, participants must purchase any bottle of Du Toitskloof wine during the competition period. The cash register slip must be kept as proof of purchase, otherwise participants will automatically be disqualified.
- To enter for the competition, participants must SMS the word "Silwerskerm" and the province in which the bottle of Du Toitskloof wine was purchased to 45633.

- SMSs are charged at R1.50 per SMS. Free SMSs do not apply. There is no restriction on the amount of entries you may submit.
- It is your responsibility to ensure that your entry is received by us prior to the closure of the competition. Any entries which are not received by us prior to the closure of the competition will not be eligible to participate, regardless of the reason for the late entry. We and our affiliates are not responsible for any entries which are not received by us, whether timeously or at all, regardless of the cause thereof. Without limitation, we and our affiliates are not responsible for any problems or technical malfunction of any telephone network or lines, computer on-line systems, servers, or providers, computer hardware or software failure or malfunction, traffic congestion (whether physical, or on the Internet, telephone lines or at any service provider, web site or other device or medium), or any combination thereof, or any other technical or other problems.
- We and our affiliates are not responsible for any injury or damage to your or any other person's computer, mobile telephone or other device used by you to enter into, or obtain any materials related to, the competition.
- It is your responsibility to ensure that any information which you provide to us is accurate, complete and up to date.
- The winner will be randomly selected by an automatic computer system and this process will be managed and supervised by independent observers in the presence of the Organiser.
- The winner will be contacted telephonically.
- The winner of the prize will be announced on 15 August 2016. In the event that the winner cannot, after reasonable efforts, be reached or cannot present the necessary cash register slip as proof of purchasing a bottle of Du Toitskloof wine during the competition period, the winner shall forfeit the prize and the Organiser may at its own discretion choose to conduct another random draw for the prize.
- In the event that you win a prize you agree to the publication of your name and to appear in person in the electronic media and the print media, and you agree, within reason, to endorse, promote or advertise our goods or services, for which no fee will be payable.

- Any costs or expenses which you may incur other than in respect of those items specifically included in a prize are for your own account.
